# RAAHAUGE'S RANGE RULES

*You are required to comply with these safety rules at all times*

## IN AN EMERGENCY:

- A. **Call 911** Our location is: 14995 River Road, Corona (Corner of River Rd and Hellman Ave)
- B. Immediately notify the Range Office at (951) 735-7981

## BEFORE SHOOTING:

- ❶ Check-in at range office prior to entering shooting range or clays course
- ❷ Be completely familiar with the operation of the weapon you are using
- ❸ At the Pistol Range, check in with the Rangemaster before entering a Bay

## WHILE SHOOTING:

- ❹ All persons shall wear Hearing and Eye protection at all times
- ❺ All spectators shall remain behind and clear of the firing area
- ❻ All weapons shall remain unloaded and pointed safely until ready to fire
- ❼ Approved targets shall be placed at the end of and below the range backstop
- ❽ Incendiaries, explosives, armor-piercing or tracer ammunition are not allowed
- ❾ Only shotgun shells in sizes of 7 ½, 8 or 9 shot are allowed on the shotgun range  
Load NO MORE than two shotgun shells in any shotgun at any time

## AT ALL TIMES:

- No alcohol or drugs are permitted on the range or clays course
- Minors must be accompanied and supervised by an adult
- Comply with all Rangemaster's instructions and posted signs
- Use your common sense always. Think Safety

**VIOLATION OF ANY OF THESE RULES SHALL, AT THE DISCRETION OF THE RANGEMASTER,  
RESULT IN IMMEDIATE EJECTION FROM THE FACILITY WITH NO REFUND**
